### ORDER:

- 1. As per the provision of Schedule-I, para-8 of NREG Act, the state is authorized to fix the rates of different tasks such that, a person working for 7 hours would normally earn minimum wages per day as fixed by the respective state Governments.
- 2. Based on the work time motion studies, the State Government have issued orders in the reference 2nd read above duly fixing rates of different tasks on piece rate basis.
- 3. In the reference 3rd and 4th read above, , rates for certain items of works were modified after a detailed analysis of the wages earned by workers under various works taken up under NREGS.
- 4. The Commissioner, Rural Development, Hyderabad has submitted a proposal further analyzing wages earned by workers in February and March 2007. As per the analysis, it is evident that certain important tasks involved in the work like lead, lift etc., if done manually are not properly incorporated in the RSSR that is currently under implementation. This is further supported by work time

and motion studies conducted by CEC. Based on the emerging information, Commissioner, Rural Development, Hyderabad proposed for increasing rates of certain tasks in the RSSR.

- 5. The Government after careful examination of the proposal of Commissioner, Rural Development, Hyderabad order the increase of certain rates in RSSR as shown in annexure to this order which shall be applicable with effect from 25.4.2007 until further orders.
- 6. In case of persons with disabilities, the rates shall be operated 30% extra over the Rural SSR rates on items of labour component only. These special rates will be allowed only when all the persons in the group belong to disabled category.
- 7. In any case the maximum wage per day shall not be more than Rs. 100/- in all the works wherever the rates of RSSR are used.
- 8. These rates shall also be applicable in other works like CLDP, Watershed etc. of Rural Development Department.
- 9. These rates are only applicable to works taken up for wage employment in Rural Development Department.

- 10. The contents of the G.Os read at references 5th and 6th read above remain unchanged.
- 11. The Commissioner, Rural Development, Hyderabad is requested to take necessary steps to incorporate the same rates in next version of software application of NREGS-AP.
