<u>Subject</u>: Clarification regarding utilization of MPLADS funds for the welfare of the <u>differently abled persons</u>

Sir/Madam,

Reference Ministry of Statistics and Programme Implementation letter No C-4/2005-MPLADS dated 28.04.2011 and subsequent letter of even number .dated 21/03/2012 on the subject mentioned above.

- 2. Consequent upon issue of the above letters, a number of Members of Parliament have approached the Ministry for allowing them to use the full entitled amount at any time in their entire tenure without the restriction of Rs. 10 lakhs to be spent per year so that a Rajya Sabha MP can utilize Rs. 60 lakhs and a Lok Sabha MP can utilize Rs. 50 lakh at any time during his/her tenure. Accordingly, the matter has been examined and it has been decided to allow Members of Parliament of both the Houses of Parliament to allocate Rs. 10 lakh per annum OR the consolidated entitled amount of their balance tenure, effective from the financial year 2011-12, at any time for giving assistance to differently abled persons as per MPLADS Guidelines.
- 2. These instructions may strictly be adhered to in implementation of MPLAD Scheme.
- 3. This issues with the approval of Hon'ble Minister, Ministry of Statistics & Programme Implementation.

Subject:-Clarification regarding utilisation of MPLADS funds for welfare of the differently abled persons-reg.

Sir /Madam,

Government have received representations, requesting that MPs be allowed to spend some MPLAD funds, in assisting physically challenged people. It has been argued, that physically challenged persons face severe hardships, and it is the general policy of Government of India, to take all possible steps, to ameliorate their condition.

- 2. The issue has been considered at length, in this Ministry. It is felt, that it would be appropriate, to allow Members of Parliament, as public representatives, to spend some of their MPLAD funds, in assisting the physically handicapped in this country, towards a better life, as a mark of their concern.
- 3. Government is aware that item No.11, of Annexure II, of the current MPLAD Guidelines, prohibits assistance to individuals. After consideration, it has been decided, that this condition be relaxed, in favour of physically challenged persons only, keeping in view the larger public good. It is, accordingly directed, that henceforth, MPs will be allowed to spend a maximum of Rs.10.00 (Ten) lakhs per year, from their MPLAD funds, for giving assistance to the physically challenged.
- 4. In order to ensure, that the fund is properly spent, it is directed that such assistance be given only for the purchase of tri-cycles and artificial limbs, for differently abled persons. It is also directed, that all applications for such assistance will be examined and approved, by the Chief Medical Officer (CMO) of the District, to ensure proper eligibility. The District authorities, under the District Collector /Deputy Commissioner, will also be fully involved in the selection of such eligible persons.

This circular will come into effect from 1<sup>st</sup> of June, 2011.
