- Gazette Notification on the Rights of Persons with Disabilities Act, 2016 (Central Act No.49 of 2016) come into force through vide Gazette No. 1074 with Notification No. S.O.1215 (E), dated: 19.04.2017, and Communicated through vide Lr. F.No. 6-5/2017(SCT), dated: 07.04.2017, by the UGC New Delhi.
- UGC vide Lr.No. F. No. 6-5/2017(SCT), Dated: 19.01.2018; UGC vide Lr.No. F. No. 6-1/2018(SCT), Dated: 11.06.2019.
- 5. Judgement dated: 15.12.2017 in WP (Civil) No. 292 of 2006 on the file of Hon'ble Supreme Court of India.

It is to inform that Government of India enacted "the Rights of Persons with Disabilities Act, 2016" has been passed by the Parliament of India and published in Gazette of India on 28th December, 2016 replacing the Persons with Disabilities Act, 1995. Also, the Ministry of Social Justice and Empowerment (Dept. of Empowerment of Persons with Disabilities) Dated: 19th April, 2017 has issued Gazette Notification through which Central Government notified 19th day of

April, 2017 as the date on which the Rights of Persons with Disabilities Act. 2016 shall come into force. Sec.102 of the RPWD Act. 2016 as follows:

"Sec.102. (I) The Persons with Disabilities (Equal Opportunity Protection of Rights and Full Participation) Act, 1995 is hereby repealed.

(2) Notwithstanding the repeal of the said Act, anything done or any action taken. Under the said Act, shall be deemed to have been done or taken under the corresponding provisions of this Act.".

Further, the Government issued spedfic instructions to all the Universities/Filigher Learning Indicates under the control of Higher Education Department, Govt. of Telangana to take necessary action immediately on the provisions mentioned under Sec. 39 (2)(d) & 47(2) of the "the Rights of Persons with Disabilities Act, 2016" and requested to furnish Action taken Report so as to file counter affidavit on the orders of the Hon'ble Supreme Court of India in LA. No. 10 of 2015 in Write Petition (Civil) No. 116 of 1998 in the Case of - Justice Sunanda Bhandare Foundation which was communicated in vide Govt. Memo No. 129/OP & MC/ A2/2018, Dt:21.01.2019.

Also, it is to inform that the Hon'ble Supreme Court of India passed orders dated: 15.12.2017 in WP (Civil) No. 292 of 2006, the Hon'ble Court Directions was communicated in UGC vide Lr.No. F. No. 6-1/2018(SCT), Dated: 11.06.2019:

In this connection, it is to state that the Under Secretary, University Grants Commission (UGC) New Delhi, through vide Lr.No. F. No. 6-5/2017(SCT), Dated: 19.01.2018 requested all the Registrars of Central, State and Deemed Universities to furnish the action taken report on the implementation of Provisions relating to Higher Education and Higher Learning Institutes.

Furthermore, the State Commissioner for the Rights of Persons with Disabilities Telangana State, Malakpet, Hyderabad through vide Lr.No. D/538/2019, Dated: 17.07.2019, requested to initiate the steps for (i) for constitution of Internal Committee for Students with Disabilities, (ii) to establish Centre for Disability Resources in consultation with the State Commissioner for PWDs under RPwD Act, 2016 as Mentor, (iii) implementation of 5% reservation in admissions in every course, (iv) inclusion of the Disability Rights subject in the Academic Curriculum, (v) Equal Opportunity Policy for PWDs as per the provisions of Section 32 & 47 of the RPwD Act, 2016 and the directions of Hon'ble Supreme Court of India, besides the instructions of the University Grants Commission (UGC) and also requested to nominate the following persons with disability as members in the Internal Committee to pursue the problems of the students with disabilities and for their redressal.
